Re: Budget Meeting 2022

At the annual budget meeting of Kuils River Primary School held on Thursday, 14 October

2021, the following was resolved:

School fees for 2022 (Gr. 1 - 7) = R1 730 per child p.a.
 10% discount will apply if full school fees for 2022 is paid by 25 March 2022.

2. Tuition Fees for 2022 (Gr. R)

R1 366,20 x 10 months (1 Feb. – 30 Nov.) = R 13 6620 (No discount or exemption applies to Tuition fees)

- 3. Parents will have the option of paying school/fees by **debit order**. Attached please find a Debit order form. Should you be interested in making use of this option, please complete the form and forward it to the Financial Officer. Debit order payments will be over ten months, e.g. 1st payment of R173.00 will be 1st February 2022 and the 10th payment will be 1st November 2022 = R1 730.00 for the year or tuition fees will be R1 366.20 per month for 10 months.
- 4. If you have any questions with regard to the debit order system, please do not hesitate to contact the finance officer.
- 5. If you do not use the debit order facility, your fees <u>must</u> be paid by the end of July 2021. You have the option of making a payment at school (CASH or CARD) but we prefer the EFT option (See banking details)
- 6. All parents with outstanding school fees and with no payment arrangements to pay it off, will be handed over to the school's collection agency, **Jaco Pienaar Debt Collectors** as per a decision confirmed in an SGB meeting. You would then be liable to pay the outstanding amount owing as well as any legal costs incurred by the Debt Collection company.

- 7. Parents may apply for full or partial exemption of school fees (**not** Gr R Tuition fees) for 2022. All necessary documentation and supporting documents must be included and completed. Application forms (South African Schools Act. 84 of 1996 Annexure A and Annexure B) will be completed by the principal of the school.
- 8. Please note NO EXEMPTION OF GRADE R TUITION FEES.
- 9. Parents of learners, who receive SASSA grants, MUST bring the necessary proof to school. These learners will automatically be exempted from paying school fees. The proof will be the SASSA card, a letter from SASSA indicating the child/ren's names and parent/guardian's name, copy of parent's ID, copy of Birth Certificate of child/ren. PLEASE SCHEDULE AN APPOINTMENT WITH THE PRINCIPAL OR DEPUTY PRINCIPAL as from November 2021 till 16 March 2022.
- 10.Payment of School fees is essential for the proper running of the school, payment of SGB staff and a host of other financial commitments e.g. water and electricity account, telephone bills, etc. THANK YOU to all those parents/guardians who have honored their commitment in paying their child's school fees for 2021.
